2. Approval for Membership Privileges The facilities of the Mountain Club are owned and operated by Four Seasons Resort Jackson Hole. The undersigned hereby applies for Membership privileges at the Mountain Club. This Application for Membership Privileges will not be acted upon unless fully completed and signed. Membership is contingent upon approval, which shall be in the Club’s sole and absolute discretion.

3. Receipt of the Bylaws The undersigned hereby acknowledges receipts of the Bylaws and agrees to be bound by all its respective terms and conditions as may be further amended from time to time.

4. Membership Privileges in the Club The undersigned hereby acknowledges that the Club Facilities are owned and operated by the Club and that Membership in the Club permits the Member to use the facilities, but is not an investment in the Club, nor does it confer on the Member any equity or ownership interest or any other property interest in the Club or the facilities of the Club, Membership does not give a Member a vested or prescriptive right or easement to use the facilities of the Club, but grants to the Member a revocable license to use the facilities. Members do not have any interest in the income of the Club and do not have the right to receive any of the Club’s assets if the Club is dissolved. A Member only acquires a revocable license to use the facilities of the Club.

5. Payment of Membership Deposits The undersigned hereby agrees to pay a non-refundable deposit equal to 50% of the Membership fee upon submitting this application. The balance, including all applicable State of Wyoming taxes, will be due upon the opening of the Club.

6. Repayment of Membership Contribution The undersigned’s Membership initiation fee minus the administrative fee will be refunded once the resigned Membership has been resold by the Club, pursuant to the Club Bylaws.

This application for Membership Privileges shall be governed by and construed in accordance with the laws of the State of Wyoming without regard to principles of conflicts of law. The undersigned acknowledges and agrees that venue for any action arising out of, or related to, this application, Membership in the Mountain Club, or the use of Mountain Club facilities shall be proper only in the District Court in and for Teton County, Wyoming.

Upon signing this Application for Membership, the undersigned authorizes the disclosure and release of information to Mountain Club for investigating the undersigned’s qualifications for Membership and authorizes those persons or entities herein to furnish information to Mountain Club.

In making this application for Membership, the undersigned acknowledges and agrees that the undersigned has conducted such investigation into the benefits and obligations of such Membership and all documents related thereto as he or she deems reasonable and appropriate.
